Patient Report Outcomes (EPRO) Reports

EPRO reports give you detailed, measure specific data for patients who have submitted a patient survey which includes one or more variables associated with a specified measure. We offer 2 pre-defined, measure-specific reports or an option to select from a list of available measure in order to build an ad-hoc report of desired data. These reports are all <u>survey centric</u>, so a patient taking multiple surveys will appear multiple times, one row per survey. ePRO Reports do not include any data summaries.



Pre-Defined Measure Specific Reports

The **Distress Report** is a pre-defined report for the **NCCN Distress Thermometer** measure. This report includes survey information (Survey Name, Assigned Date and Submitted Date) and all measure information (Overall Distress, Practical Concerns, Physical Concerns, Emotional Concerns, Family Concerns, and Spiritual Concerns). Patient reported referrals requested, specialist they are currently working with, and their top concerns are also included in this report.
